TRADITION THREE- SPIRITUAL PRINCIPLE MEMBERSHIP

"THE FALLEN WOMAN, THE QUEER CHAP & THE ATHEIST"

Understanding and practicing the spiritual principles behind The Traditions are as necessary as understanding and practicing the spiritual principes behind The Steps. Tradition Three: The only requirement for AA membership is a desire to stop drinking. This Tradition is packed with meaning. You can declare yourself in, and no one can keep you out. No matter who you are, no matter how low you have gone, no matter how grave your emotional complications, no matter your crimes. Experience has taught us that to take away any alcoholic's full chance was sometimes to pronounce a death sentence and condemn them to endless misery. To establish this principle of membership took years of harrowing experience. In our early times nothing seemed so fragile as an AA group. The following are three stories that may shed some light on why Tradition Three is an integral part of AAs Legacy. The first story is about what they used to call the "Fallen Woman." Irma Livoni was an AA member, in Los Angeles, her sponsor was Sybil Corbin. Irma became a member in 1941, just after Sybil. Sybil took her into her home for she had nothing and burned all her bridges with family and friends. Back then alcoholic women were looked down on more so then the male alcoholic. Sybil watched AA help Irma get sober, watched AA help Irma get cleaned up, watched AA help Irma get her first job in sobriety, and watched AA help Irma get her first apartment in sobriety. Then on Dec. 5th, 1941, a self-appointed group of the members signed a letter to Irma and mailed it on that Friday, Dec 5th, two days before Pearl Harbor. In the letter they stated "your attendance at group meetings was no longer desired until certain explanations and plans for the future were made to the satisfaction of this committee. This action has been taken for reasons which should be most apparent to yourself. It was decided that, should you so desire, you may appear before members of this committee and state your attitude. This opportunity will be afforded you between now and December 15th, 1941. You may communicate with us at the above address by that date. In case you do not wish to appear, we shall consider the matter closed and that your membership is terminated."

Imagine the day Irma received the letter, Los Angeles was totally blacked out because there was a real fear that the Japanese would bomb LA. She's all alone, its Christmas time, seemingly the end of the world, and the only group that had offered any hope just kicked her out. Irma went to the roof of her building and jumped to her death. Irma's sponsor, Sybil, wrote to Bill W about the incident. No one knows to what extent Bill W. was referring to Irma Livoni when he wrote the Twelve Traditions ten years later, but the phrases seem to apply: ". . . experience taught us that to take away any alcoholic's full chance was sometimes to pronounce his death sentence, and often to condemn him to endless misery. Who dared to be judge, jury and executioner of his own sick brother?"

Barry L.'s experience "The Queer Chap" also impacted change and the need for diversity, and inclusion in the early days of AA. One day, in the early days of AA, a newcomer knocked on the door of the old clubhouse in Manhattan and asked to be let in. He talked with the oldest member and proved he was a desperate case. Barry (the newcomer) stated to the oldest member: "I just came out of prison, and I am a dope fiend, I am also an alcoholic and I need help desperately." "Will you let me join your group?" In addition to being an alcoholic, Barry was a cross dressing, bleached blonde-black woman (man), ex-con, and heroin addict. At that time in New York there were no black members, transgenders or victims of other addictions. A few black people came into the early meetings and although members tried to be friend and talk to them, they usually did not stay with us. No one knew what to do, this was a new experience for everyone. One woman, one marvelous woman sat and talked with Barry for a long time, but no one knew where to start. How do you start helping somebody like this with so many problems? None of those people could give an answer. So, they called the one person that had been sober longest," they called Bill W. Bill asked "Is [she] an alcoholic?" They answered: "Oh yes we can all tell that right off the bat, we could tell!" Bill said: "I think that's the only question we ask, it's up to us to help." He added: "What would the Master do?" Not another word was said. Barry, the newcomer, plunged into 12 Step Work. He tirelessly carried AA's message to scores of people, who in turn carried the message to thousands of others and so on.

He never troubled anyone with his other difficulties (singleness purpose), AA had taken the first step in the formation of Tradition Three. Back in the early days of AA to have meetings with such vast differences between members was unheard of. Before the Traditions, groups had rules of their own as to who could be a member of AA. These so called "protective" rules resolved to admit nobody to AA, but the hypothetical class of people termed "pure alcoholics." Early members, driven by fear and anxiety, wanted no other complications. So homeless, criminals, mentally ill, merely plain crackpots and fallen women were definitely out. How wonderful it is to see the spiritual wisdom and **spirit of inclusion** that Bill W. knew would help alcoholics the best. This is such a beautiful aspect of our fellowship. No matter who you are, where you have been or where you are going, the door is always open if any **alcoholic** is looking for help.

The third story is about a member they called Ed. Ed was a power driver, a brash salesman and an atheist. He was obsessed with the idea that AA could get along better without all its "God nonsense." He would brow beat everybody about the "God Stuff" and said it was a lot of malarky for weak folks and his group didn't need it. Group members were outraged by his behaviors. The group elders pulled him aside and firmly told him he couldn't talk like that, and he'd have to cut it out or leave the group. He happily pointed out the foreword to the Big Book of Alcoholics Anonymous " the only requirement is a desire to stop drinking." Much to their dismay the elders knew they couldn't throw Ed out of AA. So, Ed not only stayed, he stayed sober month after month. The longer he stayed dry the louder he talked against God. The group was in such anguish that their charity vanished. In time Ed got a sales job that took him out of town. In a matter of a few days he had run out of money and was calling his group members for help. The members decided to let him try it himself, they thought perhaps he would learn a lesson. A couple of weeks later, one night Ed stole into a members home, unknown to the member and his family, and went to bed. While the member and a friend were having morning coffee, Ed appeared. With a quizzical smile on his lips he asked "Have you fellows had your morning meditation? "They sensed his sincerity as he shared his story of the previous few weeks. Ed told of how he was held up in a cheap hotel and all his pleas for help had been rebuffed. He felt deserted by his fellows and that this was his end and there was nothing left. As he tossed and turned on his bed, he noticed the Gideon Bible on the bureau and opened it up. Ed never elaborated any more of what he saw and felt in that hotel room. It was the year 1938 and he never drank again. When the groups members reflect back they ask themselves: "What if we had actually succeeded in throwing Ed out for blasphemy? What would have happened to him and all the others he later helped?

So the hand of Providence, early on, gave us a sign that any **alcoholic** is

Short Form: "The only requirement for membership is a desire to stop drinking." Long Form: "Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation."

TRADITION THREE INVENTORY

(The foundation of this inventory is from the A.A. Tradition's Checklist first published in the <u>A.A. Grapevine</u>)
Tradition Three: The only requirement for AA membership is a desire to stop drinking.

- 1. In my mind, do I prejudge some new AA members as losers?
- 2. Is there some kind of alcoholic whom I privately do not want in my AA group? 3. Do I set myself up as a judge of whether a newcomer is sincere or phony?
- 4. Do I let language, religion (or lack of it), race, education, age, or other such things interfere with my carrying the message?
- 5. Am I overimpressed by a celebrity? By a doctor, a clergyman, an exconvict? Or can I just treat this new member simply and naturally as one more sick human, like the rest of us?
- 6. When someone turns up at AA needing information or help (even if they can't ask for it aloud), does it really matter to me what they do for a living? Where they live? What their domestic arrangements are? Whether they had been to AA before? What their other problems are?

As Bill Sees It

Any number of alcoholics are bedeviled by the dire conviction that if ever they go near A.A. they will be pressured to conform to some particular brand of faith or theology.

They just don't realize that faith is never an imperative for A.A. membership; that sobriety can be achieved with an easily acceptable minimum of it, and that our concepts of a Higher Power and God—as we understand Him—afford everyone a nearly unlimited choice of spiritual belief and action.

Dr. Bob and the Good Old Timers Most A.A.'s simply wanted to get people into the program, rather than keep them out. This might mean overcoming inbred prejudices and crossing social, religious, racial, and national boundaries in order to carry the message of recovery to anyone, anywhere, who needed help. It also meant doing the very same things in order to accept help. And if A.A. as a fellowship never had any greater achievement, it could say that most members have done more than pay lip service to this idea.

SIGNIFICANT DATES IN AA HISTORY: 1936- AA had 10 members staying sober. At end of 1936 AA had 15 members. 1940- Bill Wilson begins writing the book Alcoholics Anonymous. Works Publishing Inc. is established to support the writing and printing of the book. 1941- Second printing of the Big Book. 1941- 1st AA prison group formed at San Quentin. March 1, 1951- Jack Alexander's Saturday Evening Post article published and membership jumped from 2,000 to 8,000 by years end. March 3, 1947- Nell Wing started working at the Alcoholic Foundation Lexington Ave. March 4, 1891- Lois (Burnam) Wilson is born. March 10, 1944- New York Intergroup Office was established. March 15, 1941- 1st AA group formed in New Haven, Connecticut. March 16, 1940- Alcoholic Foundation (GSO) and Works Publishing move from Newark to lower Manhattan- AA's first Headquarters. March 21, 1881- Anne Ripley Smith (Dr. Bob's wife) is born. March 21, 1966- Ebby Thatcher (the man who carried the message to Bill) dies. March 22, 1951- Dr. William D. Silkworth dies at Town's Hospital. March 22, 1984- Clarence Snyder "The Home Brewmeister" dies. March 23, 1936- Bill and Lois Wilson visits Fitz Mayo ("Our Southern Friend") in Maryland. While they were visiting Fitz, Bill C., a lawyer, alcoholic and gambler, who stayed with them almost a year at 182 Clinton Street in Brooklyn, New York, committed suicide in after having stolen and sold about \$700 worth of their dress clothes and luggage. He gassed himself in their oven. Bill's story, B.B.(p. 16) "one poor chap committed suicide." March 1, 1931- 1st AA group formed in London, England.
